

1) Special Agenda Items

- a. Overview of Library Priorities
 - i. Erica Cuyugan, City Librarian

Ms. Cuyugan gave an overview of the library's short- and long-term priorities. Short term priorities are focused on four areas outlined in the Strategic Plan. In the coming months, library leadership will work to align goals and objectives with long term priorities: Integrating library services into other departments and community events; Equity, Diversity and Inclusion (EDI), new collections, safety and security, facilities and maintenance.

Work will include:

- Reviewing what is being done and how to integrate the library at community events.
- Working alongside new City Equity Inclusion Officer.
- Analyzing how to bring resources and collections out to the community.
- Maintaining safety and security, developing safety protocols and continue partnership with SMDP.
- Preserve and main all library facilities, including Building Forward Infrastructure Grant and reimage areas at Main.
- Seek funding for Open+ days at Montana.


Arnold shared suggestion to extend invitation to board members when the attending community meetings as part of community engagement efforts.


